The Safe Operator Escape Room

Have you ever asked yourself these questions:

- I thought we trained them on this?
- What am I going to do when they retire and take all that safety knowledge with them?

Real-Time Protection for Your Collection – How Inland Empire Utilities Agency Turbocharged Their Collection System

The Inland Empire Utilities Agency (IEUA), a regional wastewater treatment and water agency encompassing 242 square miles in western San Bernardino County and servicing approximately 935,000 people, provides sewage utility services to seven sewer collection agencies and wholesale imported water from the Metropolitan Water District of Southern California to regional retail agencies.

In 2019, IEUA first deployed two satellite sewer monitoring units to provide real-time, low-cost monitoring at sites that historically had encountered blockage issues across the collection system. The data collected allowed IEUA to identify potential blockages before an overflow occurred. IEUA has since expanded their satellite sewer monitoring program to 25 units which have saved at least four spills; thereby protecting public health and the environment, preserving overall authority resources, and preventing asset degradation.

Due to current conservation measures in southern California and the recent change in water usage put into effect from Senate Bill 1157 (2022), GPCD (gallons per capita per day) is being reduced from 55 to 42 by 2030. With the reduction of flow and ongoing population growth, there has been an increase in solids in the system and unpleasant odors from increased hydrogen sulfide (H2S). IEUA will be deploying two more units which will provide real-time, low-cost H2S monitoring at sites experiencing issues across the collection system.

The Inland Empire Utilities Agency (IEUA), a regional wastewater treatment and water agency encompassing 242 square miles in western San Bernadino County and servicing approximately 935,000 people, provides sewage utility services to seven sewer collection agencies and wholesale

imported water from the Metropolitan Water District of Southern California to regional retail agencies.

In 2004, IEUA entered into a Mutual Aid Agreement with their Regional Contracting Agencies and other partners to provide emergency response in the event of a disruption which would affect the water service, sewer service or sewage treatment services provided by each agency. Over the years, IEUA has taken the lead in organizing quarterly meetings between the Mutual Aid partners for sewer collection training, discussions on regional system issues, and regulatory updates.

Due to the current increase in retirements and the need for hands on training for line staff, IEUA took the lead to develop a regional approach for multi-agency sanitary sewer spill simulation training. This provides the region with first-time responders the hands-on experience necessary to handle any event.

Protection from Wildfire Smoke - Adapting to Smoky Circumstances

In recent years wildfires in California have become larger and occur more often, causing extreme local and moderate regional impacts. This has led to a significant increase in the exposure we have to wildfire smoke, an exposure which has been shown to be hazardous to our health. Cal/OSHA's new regulation, Section 5141.1 Protection from Wildfire Smoke, requires employers control this hazardous exposure in the workplace, especially for outdoor workers who tend to have the highest levels of exposure. This presentation will provide the resources you need for the current problem we are all facing in California; how to adapt to the increase in frequency and severity of wildfire smoke exposure in the workplace and the regulatory requirements associated with it. Recognizing, evaluating and controlling worker exposure to wildfire smoke will also be used to discuss how we can respond to other environmental hazards which can also have negative health and safety impacts.

Safety by Design in Pump Stations and Plant Facilities

Mr. Ledbetter will be presenting on "Safety by Design" which is the concept and movement to address occupational safety and health hazards in the design process to prevent or minimize work-related injuries and risks associated with the construction, operation, and maintenance of facilities and equipment. This approach also reduces the reliance on personal protective equipment or administrative procedures by engineering out the hazards before the facility or process is built. **PRESENTER: Jerry M. Safety Incident Reporting - A Simple, Streamlined Program

One key to an effective safety program is incident and near miss reporting. But what exactly is a near miss? And how can we explain the importance of reporting small incidents to employees? Overcoming barriers to reporting, making the reporting process work for employees, and creating a system to act on and report out on action items are three keys to making a reporting program effective. Come hear a case study from Contra Costa Water District, and their recent implementation of a comprehensive safety event reporting system which has increased the
