

EARLY BIRD REGISTRATION

Register by Friday, May 27, 2022 to receive the discounted conference registration rate. Mailed early bird registrations MUST be post-marked by Friday, May 27, 2022 and accompanied with the appropriate payment to be processed. Save time by registering online!

MEMBER-DISCOUNTED RATES

CWEA, WEF or CA-NV AWWA memberships qualifies registrant for member- discounted rates, memberships will be verified. The additional cost of a non-member registration rate will be applied toward a one-year CWEA membership, unless otherwise stated on registration form.

ONLINE REGISTRATION


